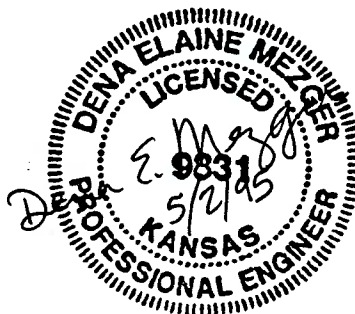
We trust that this study and the companion system computer models will be of continuing value to Manhattan in your management and improvement of the City's storm drainage system.
